Q1: Would you be able to give me a breakdown on how many cases each school will order overall and how frequently they will order through the contract?

A1: We do not have information on how many cases each school will order overall. We also do not have information regarding the frequency of the thirteen school districts plus Dutchess BOCES orders will be through the contract. We did receive overall usage information for Dutchess BOCES and our 13 component school districts from our current vendors for the period of August 26, 2022 through February 21, 2023. That information is provided below in this Addendum #1.

Q2: Will each school district only deliver to the one location or will it deliver to each school within the District?

A2: We do not have a record of where each order is delivered. Some Districts have central receiving for the District in one location and others have multiple locations. I can say that all Dutchess BOCES deliveries would go to our Receiving Dept. which is located at 5 BOCES Road, Poughkeepsie, NY 12601.
