THE FINANCE CHARGE IS COMPUTED BY A PERIODIC RATE OF 2% PER MONTH WHICH IS AN ANNUAL PERCENTAGE RATE OF 24% APPLIED TO THE PAST DUE BALANCE FROM WHICH THE CURRENT PAYMENTS HAVE BEEN DEDUCTED.
